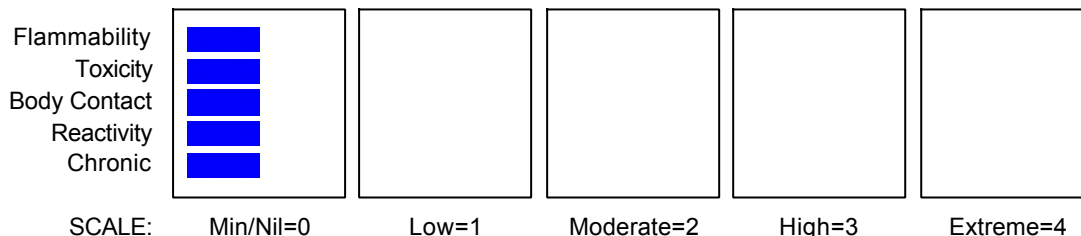

EYE
